The water utility is seeking a water treatment plant operator II. This person:

- Is responsible for water softening and purification.
- Operates filter units, including backwashes.
- Controls the flow of water through the treatment process.
- Monitors and controls the appropriate application of all chemicals used during the treatment process.
- Monitors performance of plant machinery and makes minor maintenance and emergency repairs.

#### Requirements

Must meet ONE of the following requirements:

• Completion of a post second-

ary water or wastewater treatment program.

• Two years of post secondary education with an emphasis in mathematics or chemistry.

• Two years of water or wastewater treatment plant experience to include monitoring and controlling appropriate application of chemicals; monitoring performance of plant equipment and machinery, and monitoring data, to ensure proper treatment of water.

**NOTE:** Must obtain a Minnesota Department of Health Class B operator certificate within 36 months of appointment.
