Removal of both existing furnaces and disposal. Installing a high efficiency boiler. Includes a 10 year parts and 5 year labor warranty. Have a 2 year 100% unit performance guarantee.  
 All ball valve shut offs needed. Three zone motors for each level. Three thermostats to control each levels temperature. Expansion tank, air bleeder, and air purger. A residential boiler pump with isolations valves. Low loss header with ECM circulator. Auto fill valve to control water pressure. Back-flow renovation to protect other water sources. Circuit installation to boiler location from panel. Magnetic boiler filter to protect unit. Surge protection to protect electrical. Condensate neutralizer to prevent corrosion in drain.  
 Laying piping throughout home on all three levels. Needed baseboard radiators in each room. Combustion air installation. Install a new chimney cap. Add dryer vent where new dryer is wanted.  
 All mechanical permits and inspections needed included.
