**Narrative :**

On 05/18/2022, at 1639 hours, we, Squad 163T (Htoo/Xiong) responded to 733 Thomas Ave to assist Squad 189T (Steffen/Dzik) for a Disorderly Conduct call. Comments of the call was that "COMP SEEN SOMEONE CRAWL INTO THE WINDOW OF A BOARDED UP HOUSE..THE HOUSE WAS PREVIOUSLY BURNED AND SHOULD NOT HAVE NOT HAVE ANY OCCUPANTS..ABOUT 20 MIN TIME DELAY..BELIEVES THEY ARE STILL IN THERE".

Upon arrival, We went through the back door window that was forced into. We got in the house and I began announcing myself as a Saint Paul Police Officer a couple times. I did not hear anything, but I saw a movement on the couch. I shined my flashlight at the couch and saw more movement coming from what was appeared to be a blanket.

I looked and saw two subjects, later identified as TORRES, ALMAROSA LINDA, DOB: 04/23/1997, 723 Plum St, St. Paul, MN 55106, C/P: 651-502-5937 hiding underneath the blanket with her hands underneath the blanket. I also saw DURAN-PELAIS, JORGE, DOB: 04/20/1980 hiding under the

table. I announced myself as a St. Paul Police and asked both JORGE and ALMAROSA to come out with their hands up, but they refused to come out. I took out my department issued handgun and pointed it directly at JORGE and ALMAROSA. I gave several police commands towards both JORGE and ALMAROSA to come out. JORGE and ALMAROSA stood up with their hands up. I told ALMAROSA and JORGE to walk towards me. As ALMAROSA got closer, I went and placed ALMAROSA in handcuffs (double locked and checked for tightness). I did a quick pat search on ALMAROSA and did not find anything. I ran ALMAROSA on data channel to check for any warrants at the location. ALMAROSA came back clear with no warrants. Ofc Steffen detained JORGE and placed him in handcuffs and also checked him for warrants but was unable to locate any.

ALMAROSA stated that she used to live in the the above address and stated that she has nowhere else to go. ALMAROSA and JORGE were both released on scene and I advised them not to come back to the location.

No arrest was made at this time. Officers and the suspects, ALMAROSA and JORGE, were not injured at this time as well.

Sgt. Diaz was notified.
