

### Sound Level Variance Application

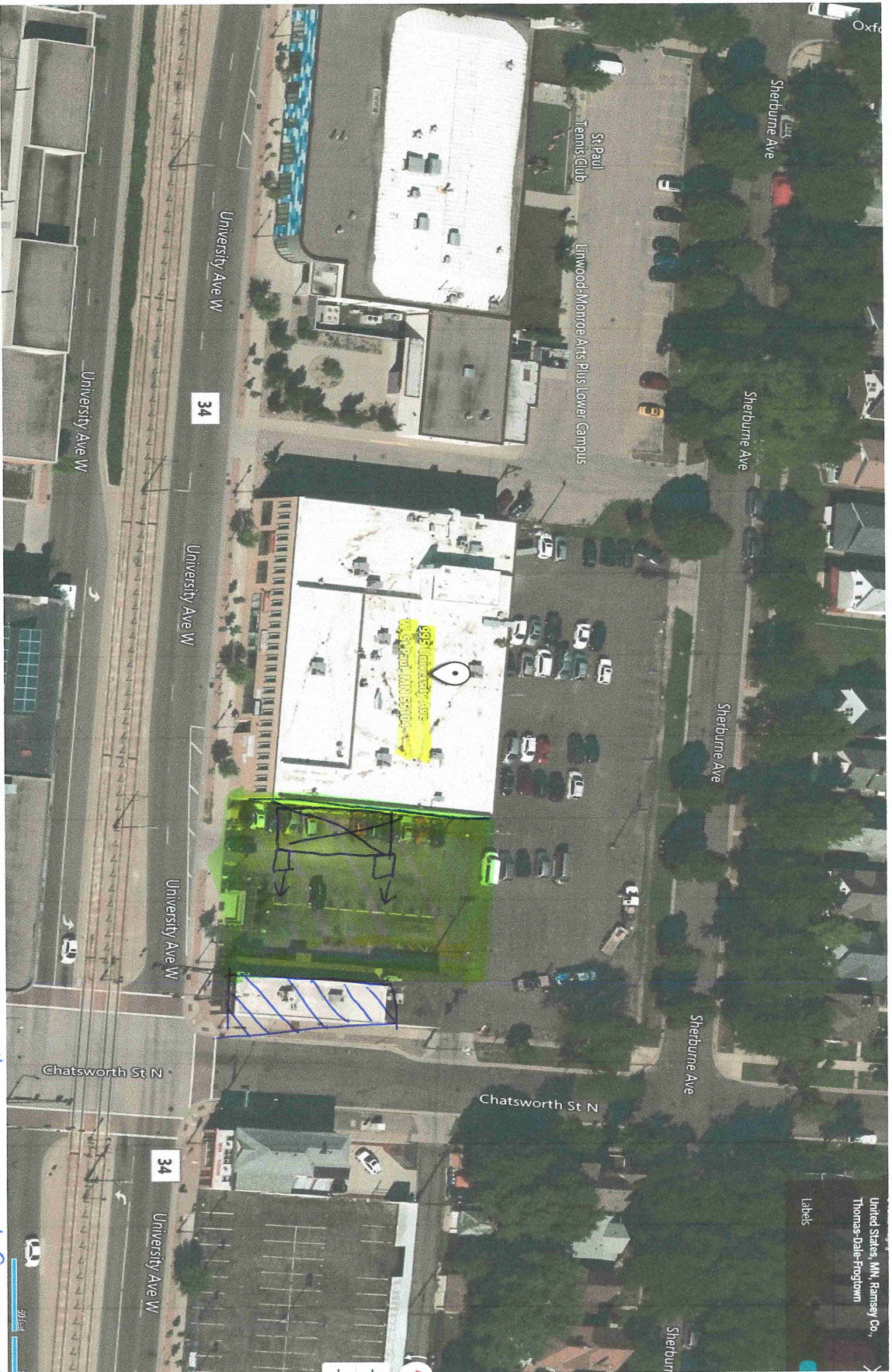

Applications submitted within sixty (60) days of the event date may not satisfy the processing timeline requirements.
