#### Synopsis :

On 07/19/2022 at 0111 hours this officers responded to a report of criminal damage to property at 1051 Arkwright St #1. Information about the incident was obtained.

On 07/19/2022 at 0111 hours I, Ofc. N. Younce (sqd. #310), responded to 1051 Arkwright Street #1 on a report of criminal damage to property. I arrived on scene and spoke with victim Tery, Breanna Nicole (DOB/1988-10-10).

Breanna showed me that someone had thrown a brick through her apartment window. Breanna did not give an estimate for the damaged window at this time.

Breanna stated that approximately a week ago she slashed a tire to her child's father's sister's vehicle. BREANNA knew the female as "JASMINE DOBIE." BREANNA believed that JASAMINE was getting her back for slashing her tire. BREANNA had no evidence that "JASMINE" damaged her window, and did not see who threw the brick. No suspect description available.

I offered Breanna the board up service but she declined.

I took pictures of the damage and uploaded them to the media vault.

JAMIE was given a card with CN.

On 07/19/2022 at 0216 hours the victim from 1051 Arkwright Street #1, Tery, Breanna Nicole (DOB/1988-10-10), called back. It was reported via call comments that "JASMINE BROKE APT WINDOW AGAIN." I, Ofc. N. Younce (sqd. #310), responded to the scene.

I spoke with Breanna who stated she was in her living room when the damage occurred. Breanna stated she ran outside to see a female running down the street towards a white Chevy Cruz. Breanna believed that this may have been one of "Jasmine's" friends. She stated the female she saw running was slimmer than "Jasmine."

Breanna stated that Jasmine owns a white Chevy Cruz and lives in South Saint Paul. I located a JASMINE DEVINE DOBIE (DOB: 02/14/1989, 1040 8TH AVE S APT 5 SOUTH SAINT PAUL) via DVS. This individual also owns a white 2016 Chevy Cruz LIC: GRE815.

I took photos of the new damage and uploaded them to the SPPD media vault.

A board up crew was contacted for the damaged windows.

I gave Breanna a victim's rights card.
