Re: Remove or Repair of the Structure at 331 Lawson Avenue West

Dear Charles Nosie:

This is to confirm that at the Legislative Hearing on October 11, 2022 Legislative Hearing Officer Marcia Moermond recommended that the City Council **remove the building within 5 days with no option to repair.**

For your reference, the following items must be completed before receiving a grant of time from the City Council to rehabilitate the property:

- 1. Past due real estate taxes must be brought current** (*currently taxes for the first half of 2022 are delinquent in the amount of \$3,614.26; second-half taxes are due October 15*);
- 2. Post a \$5,000 Performance Deposit with the Department of Safety & Inspections;**
- 3. submit evidence of financing sufficient to complete the rehabilitation.** Staff estimates costs to exceed \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case-by-case basis;
- 4. apply for a Code Compliance inspection with the Department of Safety & Inspections** (*a Code Compliance Inspection was done July 2021 and has since expired*) Your code compliance application must include lock box code and box must be attached to door for use;
- 5. submit an affidavit indicating the finances will be dedicated to completing the project** and not diverted until a code compliance certificate is issued; and
- 6. submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids and a **schedule** for completion of the project; and
- 7. the property must be maintained.**

This matter will go before the City Council at Public Hearing on **Wednesday, November 9, 2022 at 3:30 pm. in room 300 City Hall.** If you are contesting Ms. Moermond's recommendation you may:
