Synopsis :

Death Investigation.

Narrative :

On 06/10/2021 at 1435 hours I, Officer J. Pederson SQD-274, and Officer W. Everett SQD-281, were dispatched to 126 9th St. E., Apt. 7, on an Assist Medical Agency call for SPFD Medic 6, Run# 24036, officers were informed medics were out with a deceased party who had been located in the apartment.

Officers arrived on scene and made contact with SPFD Medic 6, who informed officers the deceased, identified as, Georgine Yvonne Singleton (DOB: 01/21/1962, 126 7th St. E., Apt. 7, C/P: Unknown) had been located face up laying in her bed and was pronounced deceased by SPFD Medic 6 at 1421 hours.

Officers spoke with two males, identified as, Keelan Keith Singleton Jr. (DOB: 07/08/1999, 1625 Charles Ave., C/P: 651-230-3051) who stated he was Georgine's grandson and had come to check on her. Keelan stated he had been trying to call Georgine for the last six or seven days and she had not been answering, which is uncommon for her. Keelan stated on 06/10/2021, he came over to her apartment to check on her and knocked on the door but no one answered. Keelan stated he and multiple family members had tried calling her with negative results for almost seven days.

Keelan stated on 06/11/2021, he and a family friend, identified as, Rashaan Kirk Davis (03/04/1996, 1114 Jessie St., C/P: 612-940-8264) had come back to 126 7th St. E., to check on Georgine. Keelan stated he spoke with the building manager, identified as, Richard Allan Pottvin (DOB 01/13/1965, 126 7th St. E., Apt. 10, C/P: 651-503-9318) and requested to check on his grandmother. Keelan stated Pottvin was rude to him and told Keelan and Davis "Go fuck yourself!" when asked to open the door and check on Georgine for her safety.

Keelan stated he then kicked in the main door of apartment seven and observed his grandmother, Georgine laying face upon on her bed and appeared to have been deceased for multiple days. Keelan stated they called for SPFD Medics to come assist.

Keelan stated Georgine had severe Schizophrenia, was Diabetic (Unknown type), and Bi-Polar for most of her life, although he was unsure what kind of medicine she took, or if she took any at all or if she was managing it. Keelan stated he knew Georgine would often drink, but he did not know of any other underlying medical issues Georgine may have.

Officer located a bottle Divalproex 250 mg, which is used to treat seizures and bi-polar disorders. Officers were unable to locate any other medical forms, doctor information or medication in the apartment.

Officers contacted the Medical Examiner and informed them of the situation. The Medical Examiner came and collected Georgine and transport her to their facility.

Sgt. M. McGinn SQD-420, was informed of the situation.

Officers had a board up crew come and secure the apartment.

Officers took photos of the apartment, scene, and Georgine, and later downloaded them to the SPPD Secure Media Vault.

I (Sergeant Shawn Shanley) am assigned to the Homicide and Robbery Unit for the St. Paul Police Department and was assigned this case for review and investigation. I began by reviewing all included reports and information for the parties involved, to determine the course of the investigation, as well as information gathering for possible criminal charges.

The officers on scene did not locate any evidence or information that would indicate this is a suspicious death. I reviewed the media vault pictures, and any evidence collected in the case. At this time, the death appears to be due to natural causes, and the case will be NOTED. If there is further information obtained, or if the Office of the Medical Examiner contacts us with suspicious results or alternate findings, the case will be immediately re-opened.
