Synopsis :

On 05/02/21 at 0016 hours, SPPD officers responded to a report of a burglary at 484 Robert St. N. Upon arrival, SPPD officers obtained suspect description from a witness who was nearby and witnessed the incident. SPPD officers canvassed the area and was not able to locate anyone matching the description given. The caretaker to the business was advised of the incident. No arrest.

Narrative :

On 05/02/21 at 0016 hours, I, OFC. C. MOUA (Squad 217) responded to a report of a burglary at 484 Robert St. N. (The Smallest Cog Bicycle Shop). The caller stated the suspect was last seen headed southbound on Robert St.

I arrived on scene within minutes. I met with a male, who was the caller, identified as PACO AGUILAR (DOB 05/01/75, 215 Old 6th Street, CP 612-457-6000) in front of 484 Robert St. N. AGUILAR said he was sitting out the outdoor seating area at Camp Bar when he saw a male, who appeared to be very intoxicated, looking through the window at The Smallest Cog Bicycle Shop. AGUILAR said the male then threw something shattering the window. The male then took a bicycle through the broken window and rode off with it going southbound on Robert St. turning westbound on 7th St.

Assisting squads searched the area for the suspect, but was not able to locate him or the stolen property.

AGUILAR described the male suspect as a black male, approximately 5'11 in height, wearing brown jean pants, brown hoodie with stripes along the sleeves and skinny build.

AGUILAR described the stolen bicycle as a "black shining bike".

The caretaker, identified as RICHARD POTVIN (DOB 01/13/65, 484 Robert St. N, #10, CP 763-301-0871) was also on scene. POTVIN said he did not hear or see anything. POTVIN said he came down to make his rounds and saw the window was broken so he called the police, as well.

I can see through the broken window that the suspect used what appears to be two bricks to break the window. It was not possible to climb through the window to retrieve the bricks due to the sharp broken glasses around the window. Also, we did not have access to go through the front door.

POTVIN told me the business does not have any security cameras.

POTVIN provided me with the business owner's information; AL KRAMER (CP 612-723-6612). We were not able to make contact with KRAMER.

I left a business card along with a case number for POTVIN to give to KRAMER.

I took photographs of the scene and uploaded them to Media Vault.

On 5/2/2021 at 1153 hrs, I, squad 499 (Redmond) took a follow up report to an over night burglary at 484 Robert St.

I spoke with, Mark Jon Plotz (DOB/1975-02-15), who stated he owned Smallest Cog bicycle shop. He told me his business had been burglarized overnight. He called to report the bicycle which had been stolen was a Fairdale Weekender. He told me the bike was a one of a kind build and he valued it at \$3200. He described it as Black with white lettering. He did not have the serial number for the bike.

PLOTZ sent me phots of the bicycle as well as a list of parts. The photos he emailed me were not compatible with Media Vault. The photos will be forwarded to the assigned investigator at a later date.
