If you don't wish to contest, no further action is needed and the Council will proceed with Ms. Moermond's recommendation above.

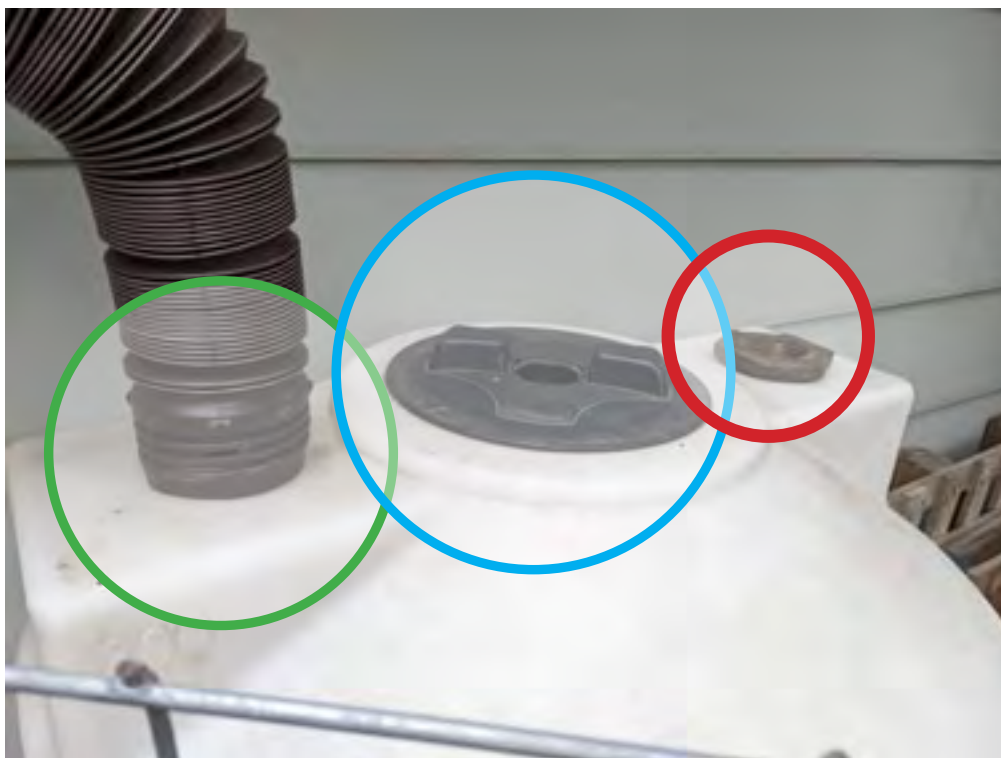

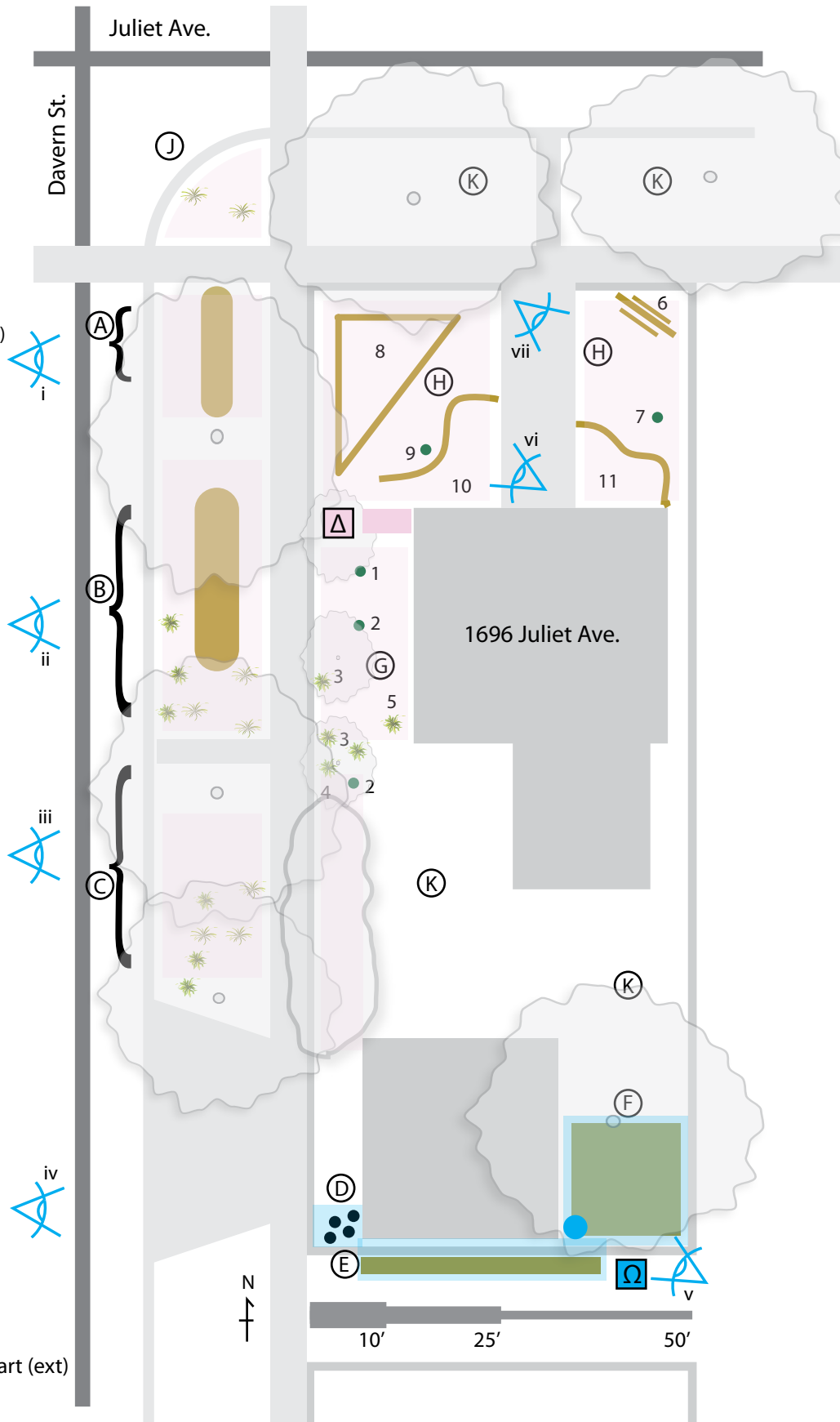
