Re: Remove or Repair of the Structure at <u>132 Western Avenue South</u>

Dear Jenny & Alfred Louismet:

This is to confirm that at the Legislative Hearing on August 9, 2022, at which you did not appear, Legislative Hearing Officer Marcia Moermond continued the matter to **Legislative Hearing on August 23, 2022 at 9 am** in room 330 City Hall.

At the August 23 Legislative Hearing be prepared to discuss status of clearing title/probate status, in addition to the items below.

## The following items must be submitted by close of business Monday August 22, 2022:

- 1. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates costs to exceed \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis:
- 2. submit an affidavit indicating the finances will be dedicated to completing the **project** and not diverted until a code compliance certificate is issued; and
- **3. submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids and a **schedule** for completion of the project.

It is a continued requirement that the property be maintained. I have included samples of these items.

This matter will go before the City Council again at Public Hearing on Wednesday, September 7, 2022 at 3:30 pm. in room 300 City Hall. If you are contesting Ms. Moermond's recommendation from the August 23 hearing, you may appear in person or send written testimony to be added to the record to <a href="mailto:legislativehearings@ci.stpaul.mn.us">legislativehearings@ci.stpaul.mn.us</a> or by voicemail at 651-266-6805. Should you wish to address Council directly but not appear in person, you
