## Good afternoon,

I'm confirming that I was finally able to meet with the property manager again on site this week to review ahead of the next appeal hearing. There are new photos added to the file for 680 Bayfield St as well but I'm not sure the photos show anything new.

After reviewing the space with Building Official Steve Ubl's comments in mind, we identified one main area of the ceiling that would be beneficial to patch. This is a sloped area of the ceiling near the base of the wall which was pointed out to the property manager. I would also suggest that they provide some sort of guardrail or physical barrier to prevent potential use of the non-sprinklered void space for storage. If these two concerns are addressed then I feel that it would be reasonable to allow the wall to remain open. This would hopefully address the concerns the appellant had about difficult access and limited working space preventing a full repair to the wall.

Please let me know if there are further questions on this ahead of the appeal. I am also currently the one scheduled to represent Fire Inspections at the hearing on 2/8 so I would be able to answer any additional questions at that time as well.
