This manager:

- Performs expert-level managerial and administrative work directing the operations of the production division.
- Provides strategic leadership and management.
- Develops divisional policies and budget.
- Oversees employee staffing, development, performance management and measures, training, discipline, and related human resources activities.
- Directs, plans, and manages activities related to the production of quality drinking water through treatment and analysis.
- Acts as liaison to the Vadnais Lake Area Water Management Organization.
- Ensures compliance with federal, state and local laws, rules, regulations and standards.
- Oversees research activities that provide compliance and planning data for effective management.

## Requirements

- A Bachelor of Science Degree in civil engineering and five years of experience as a civil engineer III – SPRWS or five years of experience as a water quality specialist III or equivalent.
- Must possess a class “A” water system operator’s certificate, issued by the state of Minnesota, prior to appointment.
- Must possess and maintain a valid Minnesota class D driver’s license, or equivalent out-of-state driver’s license.

## Staff promoted, tech analyst hired



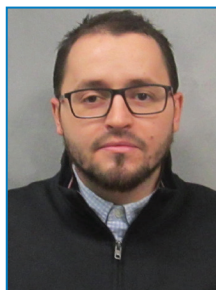
