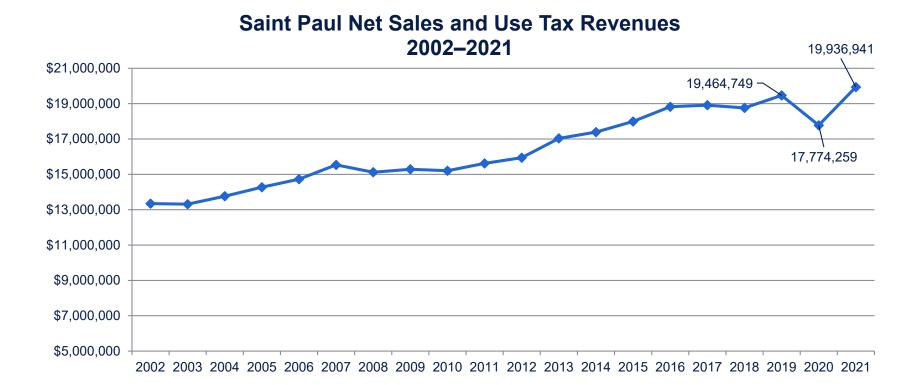

# St. Paul's Sales Tax

- Local option ½ cent sales tax in Saint Paul began in 1993
  - $\circ$  Amended 6 times
    - 1997, 1998, 2003, 2005, 2009, and 2013
- 2013 (Current Law)
  - Taxing Authority expires in 2042
  - 40% used for RiverCentre or Economic Development
  - 60% STAR Programs
    - Neighborhood STAR Capital projects
    - Cultural STAR Capital projects and Operating Support







## 2022 Sales Tax Revenue

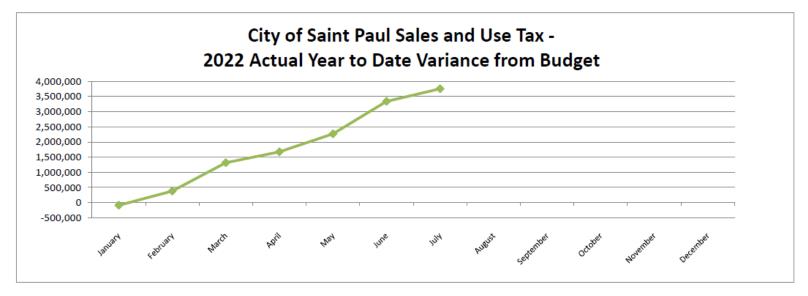
• July 2022 year to date revenues show a positive variance of 36.98%

# 2022 Sales Tax Revenue Cont.

- Collections through July 2022 are \$3,755,609 (36.98%) above budget
- 2022 collections through July are \$2,857,743 (25.85%) more than same period in 2021

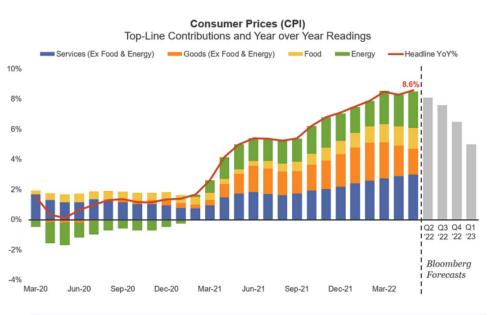


# 2023 Proposed STAR Budget - Revenue

- \$1 million (5. 6%) increase of 2023 sales tax base revenue
- \$48,739 decrease to loan repayments
- Increased interest earnings

#### <u>Takeaways</u>

- 2023 sales tax budget is at a historic high
- Recent collections have been up in large part due to inflation

# 2023 Proposed STAR Budget - Expenditures

#### Sales Tax Debt

- Proposed New Issuance 2023 Debt Service (NECC and Fire Station 7)
- 2019A RiverCentre Complex Debt Service (Arena Bonds)
- 2019B/C Refinanced Bond Debt Service (ISP and Parking Ramp)
- 2014 Economic Development Bond Debt Service (8-80 Bonds)

#### <u>Takeaways</u>

- Housing Trust Fund 5th year financing
- \$1,500,000 increase support for eligible city capital expenditures
- \$800,000 budgeted for year-round STAR
- \$647,259 decrease to Cultural STAR programs
- \$898,738 increase to Neighborhood STAR programs



### 2023 Sales Tax Revenue Bonds

- St. Paul sales tax law sunsets December 31, 2042
- Series 2014G and Series 2019A/B/C are callable August 1, 2024
- Additional sales tax revenue bond capacity
  - Sales tax bonds may be issued if it is first determined that 20 percent of the revenues derived from the tax authorized together with other revenues pledged to payment of the bonds is expected to exceed the annual debt service on the bonds, per issuance
