Dear Austin,

Thank you for contacting the City of Saint Paul about the Quarter 2 (April - June) 2022 delinquent garbage assessment. In the City of Saint Paul, garbage service is paid for in advance for quarterly service. When bills are unpaid by the end of the billing cycle (three months), they are transferred to the City for payment which zeros out the resident account with the hauler. Then a pending assessment for delinquent garbage is placed on the property for the unpaid amount.

It appears as though the quarter 2 (April - June) bill of \$111.05 for this property was not paid by the previous property owner. As a result, Republic Services sent your delinquent Quarter 2 (April - June) bill to the City which the City paid on behalf of the previous property owner. Therefore, the invoiced amount of \$111.05. is still due to the City of St Paul. Unfortunately, as the current property owner you are now responsible for any pending assessments for the property.

My recommendation to new home owners in similar situations is to contact your title specialist as they should have informed you about this assessment before closing on this property. Usually they are willing to reimburse the assessed amount, however we cannot request that they do that. You can also further contest your assessment at your scheduled legislative hearing. Our recommendation to the legislative hearing officer will be that the assessment be approved but she ultimately has the final say over whether to remove the assessment or not.

Please let us know if there is anything else our team can do for you.
