**Description of Variance:**

**Location:** 10 West 7<sup>th</sup> St – Minnesota Children's Museum

**Noise Source:** Sarah Oehlerts, MN Children's Museum Events Manager, has requested a sound level variance, for 100 dBA at no specified distance, to present amplified sound with use of a sound system for the Play Rocks! Block Party on August 13, 2022 at 10 West 7<sup>th</sup> St. The variance is requested for the hours of 9:00 a.m. to 2:00 p.m. with a sound check from 9:30 a.m. to 10:00 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 9:00 a.m. to 2:00 p.m. with a sound check from 9:30 a.m. to 10:00 a.m. on Saturday, August 13, 2022, for the Play Rocks! Block Party. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on August 13, 2022. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 2:00 p.m. on August 13, 2022.

Submit comments for Public Hearing electronically. The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday, August 2, 2022, will be attached to the public record and available for review by the City Council. Comments may be submitted as follows: Written public comment on public hearing items can be submitted to Contact-Council@ci.stpaul.mn.us, CouncilHearing@ci.stpaul.mn.us, or by voicemail at 651-266-6805. Live testimony will be taken in person in the Council Chambers, and by telephone by registering to speak by noon on the day before the meeting. The

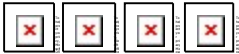
