Location: 2115 Summit Avenue – O'Shaughnessy Stadium

Noise Source: Zachary Dubois, University of St. Thomas St. Paul Campus Manager, has requested a sound level variance, for 85 dBA measured at 50 feet from the sound source, to present amplified sound with use of a sound system for Fall 2021 Commencement for 2020 Graduation, missed due to COVID-19, on October 10, 2021 at 2115 Summit Avenue – O'Shaughnessy Stadium. The variance is requested for the hours of 12:00 p.m. to 4:00 p.m. on Sunday, October 10, 2021 with a pre-event sound check from 11:00 a.m. to 12:00 p.m. on Sunday, October 10, 2021. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 12:00 p.m. to 4:00 p.m. on Sunday, October 10, 2021 with a pre-event sound check from 11:00 a.m. to 12:00 p.m. on Sunday, October 10, 2021 for Fall 2021 Commencement for 2020 Graduation, at 2115 Summit Avenue – O'Shaughnessy Stadium. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from all sound sources on October 10, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 4:00 p.m. on October 10, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits. Applicant indicates that residents of the block will be given wristbands for their families and friends as part of access and control of number of participants.

Public attendance at the City Council's regular meeting location is not feasible due to the COVID-19 health pandemic. Members of the public may view City Council meetings online at <https://stpaul.legistar.com/Calendar.aspx> or on local cable Channel 18.

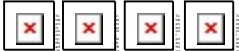
