That work would require a Mechanical Steam or Hot Water permit as to install this the boiler system would have to be modified. That radiation is actually a baseboard type and is installed horizontally near the floor "baseboard" it also has a cover that is installed over/around it to protect anyone from the scalding temperatures and sharp metal edges. As installed this is definitely a safety hazard and concern. Also, with that work being performed without permit or inspections it would leave me to question the safety of the boiler and hot water piping system as a whole.
