

Key Aspects of the 2022 Budget

Focus on restoring critical services and leveraging new opportunities Investments:

Service and staff restoration: \$4.7 million (\$1.8 million in General Fund)

Office of Neighborhood Safety (\$1.25 million)

Law Enforcement Career Path Academy (\$820,000)

Housing and Economic Development (\$1.1 million)

Other service changes (\$1.1 million)

Capital Improvement Budget: \$32.2 million over two years

Hamline Midway Library

North End Community Center

Fire Station 7

General Fund department reductions: \$372,000 \$3.3 million in budget stabilization from ARP



Council 2022 Budget Adaptations



Property Tax Levy 6.17% vs. 6.92%, a reduction of 0.75% or \$1.2M



Neighborhood Safety –Implement semi-annual police academy pilot to maintain staffing levels at current authorized strength \$1,035,000



Affordable Housing and Stable Neighborhoods



Neighborhood Development Fund \$1,600,000



Expand pedestrian and traffic calming investments


