Car 9 was called to the scene and completed the investigation with Squad 3. Investigation found the area of origin to be the stud space containing the electrical wiring for both the air conditioning unit and the walk in cooler for the store. The fire extended from the stud space upwards and outwards to the exterior and into the attic space above. Examination of the electrical panel found the breakers for the cooler were tripped most likely due to extended use of the cooler and air conditioning during the extended period of high temperatures.
