 - Youthprise funding for Saint Paul residents on Chromebook waiting list
 - Expand wifi to reach beyond library walls
 - "Internet essentials" codes for SPPS students
- Library efforts
 - Library opens limited computer access as first in-building service
 - CARES Career labs collaboration with Ramsey County
 - Continued career labs with CDBG funding
 - Digital navigator pilot
 - Emergency connectivity funding distributions: 500 hotspots for long-term check out, added chromebooks

Connectivity Blueprint Background

- COVID-19 illuminated a digital divide and disparities in access, affordability, connectivity and navigation in electronic devices
- Digital Equity as a basic need alongside housing, food, and access to healthcare
- Launched Connectivity Blueprint following CARES funded Workforce Solutions and Saint Paul and Ramsey County Libraries collaboration
- American Rescue Plan Act funded by city of Saint Paul and County.

- The initiative is led by Ramsey County, Saint Paul and a steering committee of experts.
- Aimed to create a community-guided roadmap to digital equity through understanding the current policy context and community perspectives on digital equity in Ramsey County and St. Paul.


Digital Equity Definitions










Digital Inclusion Focus: It's About People, Not Wires



Most Ramsey County Residents Have Some Internet Connection





Broadband, Laptop and Smartphone Access by Race



Ramsey/Saint Paul BIPOC Communities Started the Pandemic Behind


Describe Your Connectivity in March 2020






The Digital Divide in Ramsey/Saint Paul is Felt Today

How often do you have the technology and internet access needed to participate in online life as much as you would like to?






Rethinking the "Three-Legged Stool"

- Advance broadband policy that makes connectivity accessible to all.



Conclusions

- Digital equity is the foundation of an equitable future.
- Focus on **people**, our residents and their families, not only on wires and broadband
- The city has an opportunity to invest in digital infrastructure in a way that prioritizes digital equity through federal funding coming to the state over the next 2-5 years.
- Opportunity for multiple city departments to work in partnership, continued opportunities for metro area collaboration
- Embed digital equity in our strategic priorities work.
