I'm following up on this one regarding the conveyer obstructing an exit. Brian Schmidt was back out to take additional measurements and photos that were added to our file. Based on these measurements, this confirms that the exit from hallway and car wash area is ok without use of the obstructed door near the conveyer belt. They also have already installed signage which I feel meets the intent of what they were asked for during the hearing.
