Can you add this to the file for 1690 Orange Avenue for tomorrow's legislative hearing? Also, we need to update the staff comment section of the file to the following:

City records show that the property owner purchased the property on 10/25/2021. Although the hauler did not receive any payment from the current property owner during Quarter 4 2021, they were billed for 10/25/2022 - 3/31/2022 on their Quarter 1 2022 invoice. Since the hauler could not provide us with information on why the current property owner was assessed for Quarter 4 2021, staff recommends removing the assessment in full.

I have also spoken with the property owner and they will not be attending the legislative hearing since we are recommending deletion.
