Synopsis :

On 11/29/2022 at 0015 hours, Officers were dispatched to 1040 Grand Ave (CVS) on an alarm sounding. Upon arrival, Officers observed a single shattered window. No arrest was made. Report was made.

Narrative :

On 11/29/2022 at around 0015, I, SQD 123 (OFFICER SAE MA) was dispatched to 1040 Grand Ave (CVS) on an alarm sounding. On the CAD comments, it stated that there was a glass break.

Upon arrival, I did not observe anything in the front of the building that was suspicious. I peeked into the building and did not see anything that was suspicious as well. I then went to the rear of the building and observed a single shattered window. Next to the shattered window was a white bag and a brick. It appeared that the brick caused the shattered window. It appeared that no one entered the business.

Key holder CRAIG, Dalton Brook (DOB/1991-06-18, c/p (612)280-2814, 1887 Grand Avenue) arrived on scene and opened the front door. Assisting Officers and I cleared the business with negative results of anyone inside. Inside the business was not disturbed. CRAIG stated that they do not have video surveillance at the rear of the business, and he stated that they only have interior video surveillance.

CRAIG stated that the building management, verbally identified as DAN Sullivan (c/p 952 334 8328) might have video surveillance in the rear.

I gave CRAIG a business card with a case number.

I went to the rear but did not observe anything video surveillance that was facing toward the shattered window. There was one video surveillance, but it was facing the other way.
