Re: Remove or Repair of the Structure at <u>1508 Como Avenue</u>

Dear Christopher Boylan:

This is to confirm that at the Legislative Hearing on May 10, 2022 Legislative Hearing Officer Marcia Moermond will recommend at the City Council Public Hearing on June 8, 2022 that the City Council refer the matter back to Legislative Hearing on Tuesday, June 28, 2022 in room 330 City Hall if a \$5,000 Performance Deposit is posted by close of business June 7, 2022. Please plan on updating staff on your decision regarding rehabilitation versus removal of the property at the June 28 hearing. Additionally, at that hearing it is expected you will have a statement from your attorney on the timeline for clearing title (as well as being expected you will be working on that process between now and then).

If the performance deposit is not posted, please review your options for appearing at the City Council Public Hearing on June 8, 2022 noted below.

## <u>For your reference, the following items must be completed before receiving a grant of time from the City Council:</u>

- 1. If you are intending to have a third party rehabilitate the property, pending transfer of title, the contract used for this transaction will need to be approved by the Legislative Hearing Officer. Please note that title cannot transfer until the rehabilitation is complete and nuisance abated;
- 2. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates costs to exceed \$50,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a



line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;

- 3. submit an affidavit indicating the finances will be dedicated to completing the **project** and not diverted until a code compliance certificate is issued; and
- **4. submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids and a **schedule** for completion of the project; and
- 5. the property must be maintained.

Samples of these items will be sent at a later date. If you would like them sooner, please let me know.

The City Council Public Hearing is scheduled for **Wednesday**, **June 8**, **2022** at **3:30** pm. in room **300** City Hall. If you are contesting Ms. Moermond's recommendation, you may appear in person or send written testimony to be added to the record to <a href="legislativehearings@ci.stpaul.mn.us">legislativehearings@ci.stpaul.mn.us</a> or by voicemail at 651-266-6805. Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing here:
