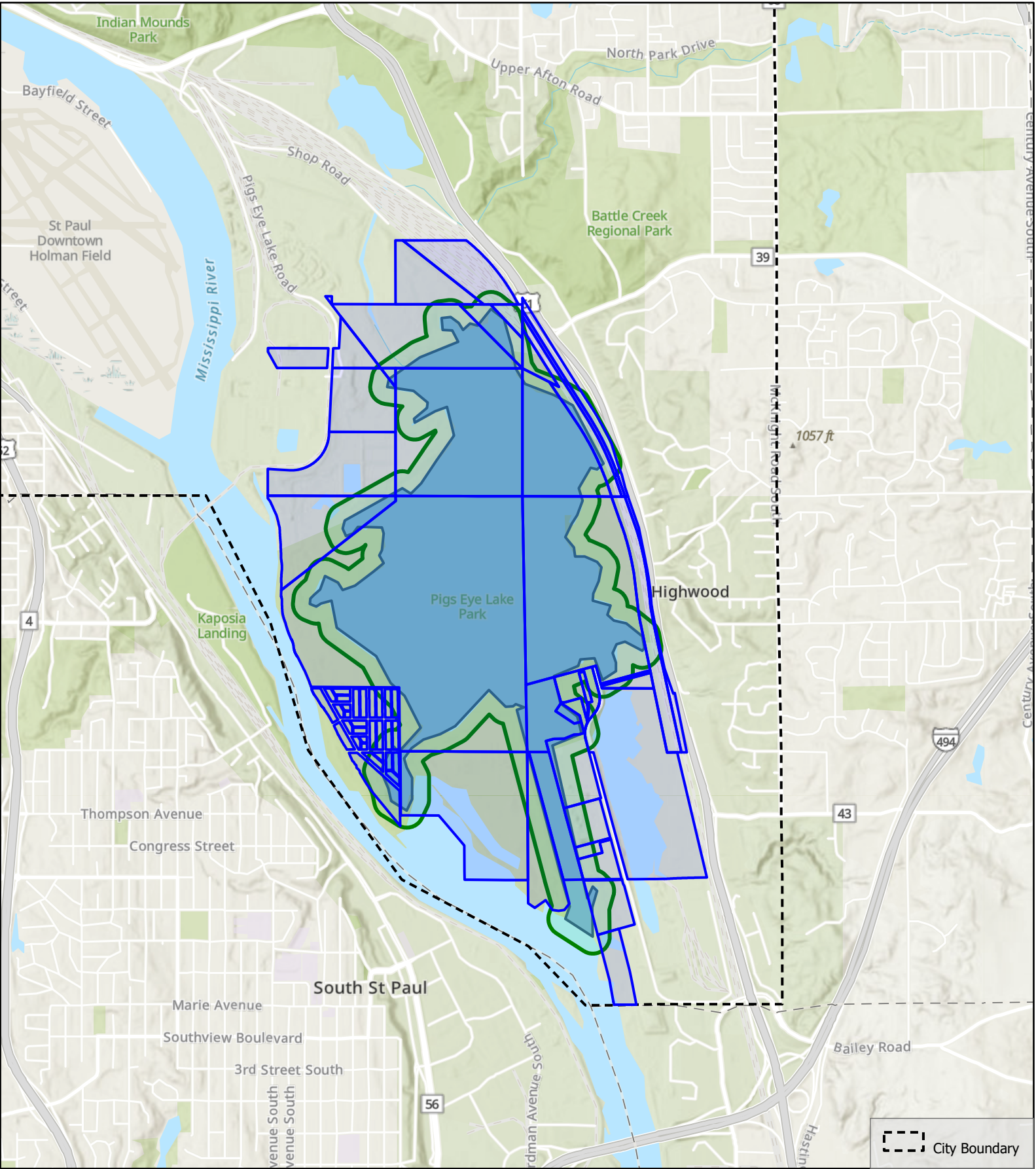
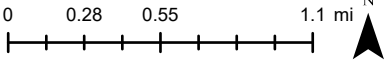


Pigs Eye Lake 350' Notification Map
