**Ticket Comments:** Property owner stated that Waste Management failed to mail the invoice to the correct address. On 7/25/2022 they called Waste Management and spoke with a Nicole, a customer service representative, who stated that it was Waste Management's fault that the invoices were sent to the wrong address. The invoice for garbage services was sent to 841 Rose Avenue in St Paul which was their mailing address almost three years ago. When the mailing address changed to 15185 15th St N, Stillwater MN 55082, the property owner called Advanced Disposal, who was the assigned hauler at the time, to update it on the account. The mailing address for the property has also been updated with Ramsey County. Therefore, the invoice should have never been sent to 841 Rose Ave. The property owner stated that the customer service agent explained that the error had occurred when the the account transferred from Advanced Disposal to Waste Management. Due to this error, the property owner stated that they should not have to pay any assessed late fees. **Please confirm whether there was an error with the mailing address and provide the following information for Q1 - Q3 2022:**

- Mailing address on file for property

- Billing method (paper, electronic, etc..)
- Itemized breakdown of invoice (including late fees)
- Payment history
- Contact with property owner
