

- 3. Mail payment to the address on the reverse side and include your name and property address.

If the assessment is approved, you will have until November 15, 2022 to pay before the City sends it to Ramsey County for collection with your 2023 property taxes. No interest is applied to this charge, but a life to the life beautiful to the cover administrative costs.

ASSESSMENT AUTHORIZATION The City of Saint Paul is authorized by ordinance to charge property owners for unpaid garbage collection charges. Unpaid fees are collected by special assessment under the authority of Minn. Stat. Chapter 443.29 and the Saint Paul City Charter by the procedure outlined in Minn. Stat. Chapter 429.

APPEAL

You can appeal the assessment/es provided in Minn. Stat. Chapter 429. In order to appeal the assessment, you must either life depitten objection prior to the City Council public hearing or present your objection directly to the Council on Wednesday, March 23, 2022 at 3:30 PM. Following the public hearing before the Council, you may appeal your assessment to the district court by serving notice of the appeal upon City Clerk within 30 days after the adoption of the assessment and filing such notice with the District Court within ten days after service upon the City Clerk.
