- 2. The removal of the construction debris and molded materials will cost approximately \$200.

- 4. The Reframing of 5 windows on main level, Replacing the glass in the 3 porch storms, repairing, scraping, painting, sashing and ensuring that windows function properly and replacing up to two windows will collectively cost \$800.
