Your building was inspected on February 23, 2022 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. A re-inspection will be made on March 24, 2022 at 1:00p.m..

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

- 1. Basement MSFC 901.8 It shall be unlawful for any person to remove, tamper with or otherwise disturb fire protection equipment.-
- 2. Basement MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-Reduce 50%

- 3. Basement MSFC 704.1, 1105.1 Provide and maintain fire rated floor and/or ceiling construction with approved materials and methods. This work may require a permit(s). Call DSI at (651) 266-8989. The minimum rating must be 1 hour-
- 4. Building SPLC 34.09 (4) a, 34.33 (3) a Repair and maintain the window glass. Windows shall be fully supplied with window panes which are without open cracks or holes.-
- 5. Front porch MSFC 313.1 Fueled equipment, including but not limited to motorcycles, mopeds, lawn-care equipment and portable cooking equipment, shall not be stored, operator or repaired within a building.-Remove grill from the front porch
- 6. Front porch MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-Remove storage charcoal lighter fluid from front porch
 - 7. Unit V- Various locations MSFC 604.4 Discontinue use of all multi-plug adapters.-
 - 8. Unit 1- Various locations MSFC 604.5 Discontinue use of extension cords used in lieu of permanent wiring.-
- 9. Unit 1-MSFC 1031.2, 1031.3 Remove the materials that cause an exit obstruction.

 Maintain a clear and unobstructed exit path.-Remove dresser and storage shoes from the exit ways
 - 10. Unit 1-MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-remove charcoal from kitchen
- Unit 2 MSFC 1031.2, 1031.3 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exit path.-Remove all storage from landings. You have storage hanging over the guardrail leading upstairs
 - 12. Unit 3-MSFC 604.5 Discontinue use of extension cords used in lieu of permanent wiring.
 - 13. Unit 3-MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-Remove propane from kitchen

- 14. Unit 3-MSFC 705.1 -- Repair and maintain the door closer.
- 15. Unit 3-SPLC 34.14(1) Provide and maintain light and ventilation in all habitable rooms in accordance with the building code in effect at the time of construction or as altered/modified under an approved building permit.-Remove blankets from windows.
- 16. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
- 17. MSFC 315.3.3 Remove combustible storage within 36 inches of fuel burning equipment.-
- 18. MSFC 603.5.3 Provide clearance around all mechanical equipment.-
