Mother was moved to assisted living facility in last year. They called Advanced Disposal in October after to cancel service. After receiving notices about an unpaid garbage invoice, they called Advanced Disposal again to pay the invoice over the phone. When they spoke with CSR, they stated that the property owner had a credit on the account but that the property owner would have to speak to the city about the assessment. They have been paying garbage bills, despite the property still being vacant. According to city records there was a vacancy request submitted on 11/15/2021 that should have been applied.
