I Judy Salaba talked yesterday 4/26/22 to the United States Postal Service at 1715 West 7th St, St Paul, MN 55116.

I talked with Janet the supervisor and Tony, I told her about my letter from the city and she said she had never heard of such a thing. She said it is my mail box and I have the right to put up a sign. It is a rural route mail delivery and there is no parking in front of your mail boxes allowed. I get my medications, needles and insulin in the mail and if someone is parked in front of your mail it goes back to the post office. When I didn't have the no parking on my mail sometimes I didn't get my mail for 2-3 day sometimes. I have lived on Rockwood Ave for 69 years and it has always been a rural route.

When someone would park in front of our mail box we were told to call the police and let them know, they would come out and give them a warning, which is a waste of time for our police. I talked to another Postal service and they told me if it happens with someone parking in front of your mail box call the police. This is a waste of time and against our rights. Please come up with something that works for all of us.

If you do not correct the nuisance or file an appeal before April 28, 2022, the City will correct the nuisance and charge all cost, including boarding costs, against the property as a special assessement to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260 per hour plus expenses for abatement.

APPEALS:You may appeal this order and obtain a hearing before the Legislative Hearing Officer by completing an appeal application before the deadline noted above or seven (7) days after the date mailed, whichever comes first. No appeals may be filed after that date. You may obtain an appeal application from the City Clerk's Office, Room 310 City Hall, 15 W. Kellogg Blvd., St. Paul, MN 55102. (651) 266-8688. You must submit a copy of this Order with your appeal application.

WARNING: If violations are not corrected by the compliance date, the city's costs will be assessed to the property taxes of the related property. If additional new violations are discovered within the next 12 months, additional charge may apply.
