This complaint is addressing a temporary situation. We are adding gardens to our alley, and that's a pretty big job- hence, the reason why it is not done in a day. Particularly since doing any kind of project with two young kids can take 10 times as long.

To address the specifics listed the complaint:

large plastic tanks--> there is one tank. It is a rain barrel. The contractor hired to connect it will be coming mid June.

black steel barrels--> these are rabbit-free garden beds, which can be easily assessed by the fact that there are vegetables growing in them. I bought and installed those last year from another resident in St Paul, so I'm surprised to hear that they violate any ordenances, and, when I read Chapter 45 I did not find anything that sounds as though they do.

child's car seat--> is gone. When on the curb it was labeled with a "free" sign, an indication that it was not a delinquent and careless scattering of trash.

Pile of "dirt"--> this is garden soil, delivered by Gertens and being used to fill aforementioned garden beds. I have been extremely careful to ensure that it blocks neither sidewalk nor street- it is located entirely in our driveway.

Tarp and boards--> these were both quite clearly being used to protect the garden soil we paid for from being washed away in one of the many storms that St Paul appears to get at regular intervals. We removed them after receiving this notice, which is unfortunate as they were serving a purpose.

There is no "miscellaneous debris" around our home, only what is obviously the project of newcomers who are working on their yard. Incidentally, yard improvement adds value to a neighborhood and is beneficial to the local environment, which we have been considering actively the entire time-- thus, why we are planting butterfly-friendly plants and collecting rainwater!

We received the Summary Abatement notice today, May 25, the same day that it says on the face of the document we are required to comply. I called you twice today but received no response, and believe that under city ordinance we are entitled at least 10 days to respond or appeal, according to your appeals website, which does not appear to be possible under the notice we received, which is dated May 18.

Is this how St Paul welcomes new people? What a disappointment. We are taxpayers and voters here, and I hope the situation improves.




