This email is to confirm that at yesterday's legislative hearing Ms. Moermond will recommend at the February 9, 2022 City Council public hearing that the City Council **continue the matter to July 13, 2022. If you have no same or similar violations (meaning no founded orders are written to your property), they reduce the assessment from \$498 to \$250. If there are violations, she will recommend the assessment is approved and made payable over 5 years.**

The City Council Public Hearing is scheduled for February 9, 2022 at 3:30 p.m. in room 300 City Hall.
