Housing Strategy: Analysis

The only constant is change!

- Continued pandemic impacts on housing stability
- Influx of federal funding for affordable housing
- Staff transitions
- Social reckoning and racial trauma





Housing Strategy: Analysis


Some changes helped; others hurt

- Covid recovery funding has enabled the City to:
 - Fund deeply affordable units
 - Provide Emergency Rent Assistance
 - Maintain and sustain shelters for unsheltered residents
- Deeper focus on equity has increased the number and capacity of developer partners that are Black, Indigenous, or persons of color.
- The pandemic impacted our ability to administer certain programs at the scale intended (Families First, Rondo CLT)
- Staff turnover has limited capacity, and some programs have been paused (DPA, Rental Rehab)



Housing Strategy: What's Next?

- Establish guiding principles how we do the work is as important as the work itself
- Make some tweaks to Housing Strategy objectives
- Dig deeper into each objective to develop more specific priorities
- Set goals and benchmarks for evaluation





Housing Strategy: Guiding Principles

Data driven and prioritized

- Establish data-informed priorities that consider deepest needs first
- Balance immediate needs with longer term goals

Transparent and responsive

- Transparency mitigates risk which in turn attracts development
- Use resources strategically and holistically
- Be flexible when possible while improving consistency in general

Equitable and accountable

- Approach every aspect of our work from an anti-racist lens
- Use data-driven priorities to evaluate outcomes

Housing Trust Fund: Outcomes

Over \$10.5M budgeted since 2019

Program	Amount budgeted 2019-2022	Outcomes
4d program	\$234,603	2,244 affordable units preserved
Shelter Support	\$1,287,244	Program Home through March 2022
Repurposed Bridge Fund	\$540,000	Emergency BIPoC Developer Training
Rondo Community Land Trust	\$100,000	Capacity building
Long term affordable homeownership	\$1,000,000	11 projects awarded; 2 completed, 7 underway
Down Payment Assistance	\$1,500,000	38 households served, 23 pending
Families First Pilot	\$3,000,000	95 families referred; 65 enrolled, 4 pending
Inspiring Communities	\$2,500,000	Recently allocated, anticipated to create 13-20 affordable housing units
PED and OFE staffing	\$585,665	Senior Project Manager (PED), Fair Housing staff (OFE)
TOTAL	\$10,747,512	



Housing Trust Fund: What's next?

Approximately \$6M in available HTF programming for 2023

Program	Proposed budget 2023	Anticipated outcomes
4d Program Administration	\$110,000	1,000 additional affordable units preserved
Rondo Community Land Trust	\$1,000,000	15 additional households served
Down Payment Assistance	\$2,000,000	35 additional households served
Preservation Program	\$3,000,000	2023 solicitation for NOAH and other preservation
PED and OFE staff	\$249,759	Senior Project Manager (PED), Fair Housing Staff (OFE)
TOTAL	\$6,359,759
