Hello Lee,

I spoke with WM and they confirmed that the previous property owner had passed away. This was communicated to them by the pervious property owner's relatives in August 2021. Since the customer service representative never put in a request to hold garbage pick up, WM recommended that we remove the following garbage

assessments that are currently pending for your property:

Delinquent Garbage Bill January to March: \$101.36 Delinquent Garbage Bill April to June: \$96.58

Since both will have to be removed via a public hearing, you probably won't see them fully removed until November 2022. However, you should be notified when they have been removed. Please let me know if you have any additional questions or concerns.
