Radulescu, his wife, parties of the first part, and the City of Saint Paul, a municipal corporation; the Northwestern Bell Telephone Company, a corporation incorporated under the laws of the State of Iowa; and the Northern States Power Company, a corporation incorporated under the laws of the State of Minnesota, parties of the second part;

WHEREAS, the parties of the first part are the owners of the several pieces and tracts of land hereinafter described, located in the County of Ramsey, State of Minnesota, to-wit:

Lots One (1) to One Hundred Thirty-five (135), inclusive, Lane's Edgouabe Hills, according to the plat thereof on file and of record in the office of the Registrar of Titles in and for Ramsey County, Minn.

WHEREAS, the City of Saint Paul, a municipal corporation, is desirous of constructing and maintaining certain sewers to serve certain portions of the above described premises, and

WHEREAS, the Northwestern Bell Telephone Company and the Northern States Power Company are desirous of constructing their lines of telephone and electric service over and across the several

parcels above described, and

WHEREAS, there is attached hereto, marked Exhibit "A", and made a part hereof, a plan of the said Lane's Edgcombe Hills, upon which plan there is a legend describing the symbols used upon the said plan to locate and describe the portions of the said premises to be used for the purpose of the furnishing of such service, and to locate the installations to be made.

NOW, THEREFORE, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, receipt of which is hereby acknowledged by the parties of the first part, the said parties of the first part hereby grant unto the said parties of the second part and to their successors and assigns a perpetual easement and right to enter upon and across the said premises within the lines indicated upon the said plan for the purpose of erecting, installing, maintaining, repairing and removing such sewer pipes including service connections, poles, guy wires, and telephone and electric wires as are necessary to furnish such services to the occupants thereof, and only over and across the said portions of the said lots as are described upon the said plan.

IT IS FURTHER understood that the Northwestern Bell Telephone Company and the Northern States Power Company are to use the same poles for their joint services; that the said poles and guy wires shall be located upon the portion of the premises described in the plan and as located therein, and that the said wires crossing the said premises shall be used for distribution lines and shall not be used for lines in excess of five thousand (5,000) volts.
