This is to confirm that at the City Council Public Hearing on August 10, 2022 Legislative Hearing Officer Marcia Moermond will recommend the matter is referred **back to Legislative Hearing on August 23, 2022 via phone between 9 am and 11** am <u>if the \$5,000 Performance</u> <u>Deposit is posted and new Code Compliance Inspection is applied for by close of business August 5, 2022.</u>

This matter will go before the City Council on Wednesday, August 10, 2022 at 3:30 pm. in room 300 City Hall. If you are contesting the recommendation (or you did not post the Performance Deposit or apply for the Code Compliance Inspection) you may appear in person or send written testimony to be added to the record to <a href="legislativehearings@ci.stpaul.mn.us">legislativehearings@ci.stpaul.mn.us</a> or by voicemail at 651-266-6805. Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing here: <a href="https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony">https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony</a>. If you don't wish to contest, no further action is needed and the Council will act on the recommendation above.

For your reference, the following items must be completed before receiving a grant of time from the City Council to rehabilitate the property. Please plan on discussing/reviewing these items on August 23:

- 1. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates costs to exceed \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;
- 2. submit an affidavit indicating the finances will be dedicated to completing the project and not diverted until a code compliance certificate is issued; and
- **3. submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids and a **schedule** for completion of the project; and
- 4. the property must be maintained.
