Council President Amy Brendmoen and members of the City Council:

We are writing to support the DSI and ALJ recommendation of an adverse action against the cigarette/tobacco license for Mounds Park Market, 241 Earl Street.

This matter is before the council following the Administrative Law Judge recommendation by Jessica A. Palmer-Denig that the cigarette/tobacco license for Mound Park Market be revoked. We are pleased by that recommendation and support it. The Saint Paul ordinance related to the sale of flavored tobacco is clear. This ordinance is obeyed by the vast majority of Saint Paul tobacco vendors. Recently ANSR staff and partners visited 147 of Saint Paul's tobacco license holders and observed good compliance with Saint Paul's tobacco regulations. To ignore the misdeeds of this license holder is a slap in the face of the many of vendors who uphold the law. This vendor is choosing profits over both health and the regulations the council has enacted. And, they are doing it in a dramatic way.

Mounds Park Market's violations are not simple mistakes. The license holder stocked vast amounts of flavored tobacco products and hid them to avoid detection. Further, ANSR staff and volunteers have directly observed their willful violation of the Saint Paul flavor ordinance. On March 14, 2022 ANSR conducted a survey to determine compliance with the city's tobacco ordinance. At that time the clerk sold to the ANSR volunteer a pack of Newport cigarettes without a tax stamp. The clerk actually gave our volunteer a receipt for the purchase. This store is not allowed to sell flavored tobacco products. No store is allowed to sell untaxed tobacco products. Further, the receipt provided to ANSR was incomplete suggesting that their might have been further illegal behavior related to accurately recording sales. A copy of the receipt and a photo of the pack of Newport cigarettes is attached.

The license holder suggests that because he was not present to supervise the purchasing and sales from the store he should be excused. The tobacco license he holds is not a right, it is a privilege. He must follow the requirements of the law whenever the store is open, not whenever he is available to supervise it. This is a shameful excuse for repeat willful violations of the city code.

Ignorance of the law cannot be claimed. In addition to the education provided to vendors by DSI as documented in the complaint, ANSR sent all licensed vendors print materials that inform vendors what products are legal and which are not. These materials are graphic with easy to understand pictures so people with limited English language can easily understand the law's requirements. ANSR offers and promotes free online vendor training so managers and clerks can comply and avoid license violations. The goal is compliance, not catching people doing wrong.



During many public hearings before this body, tobacco vendors express their support for enforcement and express their displeasure with 'bad actors.' Based on this vendor's violation, he is one of those bad actors.

The health of the community deserves to be protected from flagrant violators. We encourage you to impose an upward departure for this vendor.
