The variances are requested for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. on Saturday, March 11, 2023 for the MNUFC v New York Red Bulls game and on Saturday, March 25, 2023 for the MNUFC v Vancouver Whitecaps game. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on March 11, 2023 and on March 25, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:30 p.m. on March 11, 2023 and on March 25, 2023.
