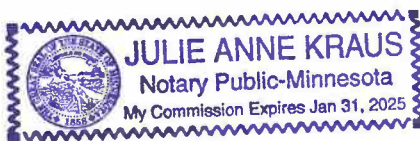

**NOTICE OF VIOLATION
AND REQUEST FOR IMPOSITION OF
\$500 MATRIX PENALTY**

RE: Auto Repair Garage license held by Pronto Auto Repair Inc. d/b/a Pronto Auto Repair for the premises located at 1054 Payne Avenue in Saint Paul.
License ID #: 20130001947

Dear Licensee:

The Department of Safety and Inspections ("Department") has recommended adverse action against the Auto Repair Garage License held by Pronto Auto Repair Inc. ("Licensee") herein for the premises known as Pronto Auto Repair located at 1054 Payne Avenue ("Licensed Premises") based on violations of your license conditions as well as a violation of the Saint Paul Legislative Code.

Saint Paul Legislative Code section 310.06 sets forth a variety of reasons on which adverse action may be based. Section 310.06(b)(5) states that adverse action can be pursued for failure to comply with a condition set forth in the license. Additionally, section 310.06(b)(6)(a) states that adverse action can be pursued for failure to comply with provisions of the Saint Paul Legislative Code reasonably related to the licensed activity.

The Department asserts that the following facts, along with photos of the violations attached herein, constitute proof that you have violated license conditions #1, #3, #4, #10, and #11, Section 65.701 of the Saint Paul Legislative Code.

Synopsis of alleged facts:

On October 24, 2022, a Inspector Joseph Voyda went to the Licensed Premises to conduct an inspection after receiving a complaint. During the inspection, the inspector observed violations of the assigned license conditions, specifically, conditions #1, #2, #3, #4, #6, #9, #10 and #11. On October



27, 2022, Inspector Joseph Voyda mailed a Correction Notice to the Licensed Premises that documented all the violations he had observed. The Correction Notice gave the Licensee until "on or before 11/11/2022" to correct the violations and stated that a reinspection would occur.

On November 17, 2022, Inspector Luis Sanchez-Panadero conducted a follow-up inspection of the Licensed Premises. Upon arrival, he spoke with employee Jessica and told her he was there for a re-inspection. The license holder Enrique Estrada was present at the time of the re-inspection. During the inspection, Inspector Sanchez-Panadero observed and documented with photos violations of license conditions #1, #3, #4, #10, and #11. He also documented a violation of section 65.701 of the Saint Paul Legislative Code. Inspector Sanchez-Panadero offered to show Mr. Estrada all the license condition violations but he did not respond.

Violation #1 - Failure to follow approved parking plan in violation of Condition #1 (See Photos #1, 8, 9, 10, and 15):

License condition #1 of the License for the Licensed Premises states that:

"All customer and employee vehicles must be parked in accordance with the approved parking plan on file with the Department of Safety and Inspections (DSI) dated 06/24/2019. A maximum of six (6) vehicles may be parked on the property at any time."

Violation #1 Facts: On November 17, 2022, during the re-inspection, Inspector Sanchez-Panadero discovered a Black Kia (MN Lic # ENP 314), Silver Honda Civic (MN Lic # DCR 411), Blue pickup truck (WI Lic #TR3785), Blue Chrysler Town & Country (MN Lic # DLM 362), Silver Jeep, and a White tow truck parked in an area that was not approved on the parking plan. Inspector Sanchez-Panadero's photos of this violation are attached as exhibit XX.

Violation #2 - Exterior storage of materials associated with the business in violation of Condition #3 (See Photos #2, 3, 4, 5, 7, 11, 12, 13, 14, 16, 17, 18, 20, 31, 32, 33, 34, 35, 38, 39, 40, and 41):

License condition #3 of the License for the Licensed Premises states that:

"There shall be no exterior storage of vehicle parts, tires, oil or any other similar materials associated with the business. Trash will be stored in a covered dumpster or inside the building. Storage of



vehicle fluids, batteries, etc. shall be in accordance with the Ramsey County Hazardous Waste regulations."

Violation #2 Facts: On November 17, 2022, during the re-inspection, Inspector Sanchez-Panadero discovered empty oil drums, gas cans, car batteries, paint buckets and outdoor storage of vehicle parts, tires, tire rims, and oil tanks on the Licensed Premises.

Violation #3 – Vehicles parked on public right-of-way in violation of Condition #4 (See Photos #21, 22, 23, 24, 25, 26):

License condition #4 of the License for the Licensed Premises states that:

"At no time shall customer, employee, and/or business vehicles be parked in the driveway or in the public right of way (e.g., street, alley, sidewalk, boulevard, etc.). This includes, but is not limited to vehicles awaiting repair, and/or that have been repaired and are awaiting pick-up by the owner of the vehicle."

Violation #3 Facts: On November 17, 2022, during the re-inspection, Inspector Sanchez-Panadero observed four vehicles parked in the right-of-way which one of them belonged to the business manager. The vehicles were a white Infiniti Qx4 (No plates), burgundy Pontiac SUV (MN Lic #JGE 425), purple Ford F-150 (MN Lic #KAG 704), and a black Cadillac Escalade (MN Lic #JTR 632).

Violation #4 – Failure to provide maneuvering space for vehicles on the property in violation of Condition #10 (See Photos #1, 8, 9, and 10):

License condition #10 of the License for the Licensed Premises states that:

"Provide maneuvering space on the property to allow vehicles entering and exiting the site from the street to proceed forward. Backing from the street or on to the street is prohibited."

Violation #4 Facts: On November 17, 2022, Inspector Sanchez-Panadero observed and documented four vehicles blocking the maneuvering space of other vehicles that was parked on the Licensed Premises.



Violation #5 – Licensee failed to comply with all federal, state and local laws violation of Condition #11 (See photos #3, 4, 5, 11, 13, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, and 42):

License condition #11 of the License for the Licensed Premises states that:

"Licensee must comply with all federal, state and local laws."

Violation #5 Facts: On November 17, 2022, Inspector Sanchez-Panadero observed gas cans, buckets containing vehicle fluids, car batteries, oil drums, oil tanks, propane tanks, battery jump pack, and miscellaneous vehicle parts that was not properly store.

Violation #6 – Failure to keep repair work in enclosed building or fenced area in violation of section 65.701 of the Saint Paul Legislative Code:

Under section 65.701 of the Saint Paul Legislative Code, all repair work shall be done within an enclosed building. All vehicles awaiting repair shall be stored in an enclosed building or within an area enclosed by a wall or fence (not including cyclone fence with vinyl slats) that provides an opaque screen.

Violation #6 Facts: On November 17, 2022, Inspector Sanchez-Panadero observed and documented three vehicles parked on a public street awaiting repair.

Under Saint Paul Legislative Code section 310.05, these violations are first-time violations. The penalty matrix laid out in section 310.05 prescribes a \$500 fine for a first-time violation.

You have four (4) options to proceed:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **January 24, 2023**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council Consent agenda for approval of the proposed remedy.
2. You can pay the \$500 matrix penalty. If this is your choice, you should make payment directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul,

Minnesota 55101-1806 no later than **January 24, 2023**. A self-addressed envelope is enclosed for your convenience. Payment of the \$500 matrix penalty will be considered a waiver of the hearing to which you are entitled.

3. If you wish to admit the facts but you contest the \$500 matrix penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **January 24, 2023**. The matter will then be scheduled before the City Council to determine whether to impose the \$500 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
4. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge ("ALJ"). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **January 24, 2023**. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

Please note: If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing per Saint Paul Legislative Code section 310.05(k).

If you have not contacted me by January 24, 2023, I will assume that you do not contest the imposition of the \$500 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.

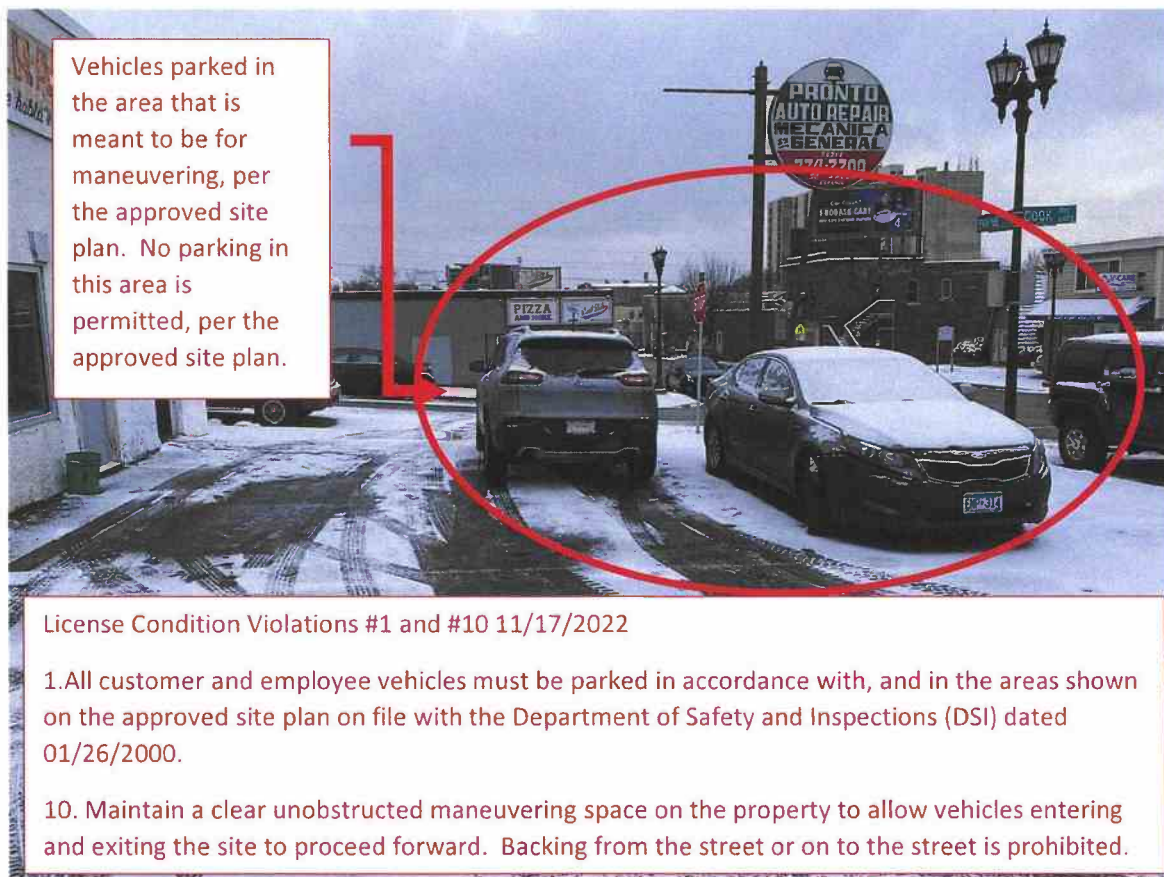
