TENTH RIDER

TO

AGREEMENT

THIS AGREEMENT, is made this 14th day of February, 2023, by and between the BOARD OF WATER COMMISSIONERS OF THE CITY OF SAINT PAUL (the "Board"), and the CITY OF VADNAIS HEIGHTS, Ramsey County, Minnesota (the "City") being the Tenth Rider to that certain Agreement made by and between said Board and said City (previously The Village of Vadnais Heights) the 20th day of June 1967 ("Agreement"), and by this reference incorporated herein and made part and parcel hereof with the same intent, purpose, and effect as if said Agreement were set forth herein, verbatim.

WHEREAS, the Board now possesses title to property in, over, and across certain real estate described as Blocks 4, 5, and 6 of Michaud and Michaud's Rearrangement of Lots A, B, C, D, and E of Vadnais Lake Villa Addition, according to the recorded plat thereof (the "Premises"); and

WHEREAS, stormwater drainage infrastructure containing approximately 40 linear feet of 15" reinforced concrete storm sewer, approximately 26 linear feet of 18" reinforced concrete storm sewer, a storm sewer manhole with a rim elevation of 886.00 / invert elevation of 883.05, and an outfall into the west arm of Vadnais Lake at elevation 883.00 including erosion control protection and stormwater drainage infrastructure containing approximately 80 linear feet of 15" reinforced concrete storm sewer and an outfall into the west arm of Vadnais Lake including erosion control protection at elevation 883.00 is needed to control stormwater at and near the proposed development known as The Elevage in the City of Vadnais Heights; and

WHEREAS, the Board is willing to grant permission for the construction of the stormwater drainage infrastructure within its property via permit agreement with the development company providing that upon its completion all components of the system within the Board's property become the property of the City and is maintained by the City thereafter; and

WHEREAS, the City has agreed to accept ownership and maintenance responsibilities for said stormwater drainage infrastructure located in said Premises; now, therefore, be it

AGREED, in consideration of the mutual promises and agreements of the parties hereto, that subject to all terms and conditions contained in the Agreement, the Board hereby grants to the City permission to enter upon portions of said Premises and to there within maintain, and carry out all Board approved operations in respect to the following and as indicated in Exhibit A, attached hereto and incorporated herein by reference:

1. Permitted Activity

Own and maintain the proposed stormwater drainage infrastructure containing approximately 40 linear feet of 15" reinforced concrete storm sewer, approximately 26 linear feet of 18" reinforced concrete storm sewer, a storm sewer manhole with a rim elevation of 886.00 / invert elevation of 883.05, and an outfall into the west arm of Vadnais Lake including erosion control protection at elevation 883.00.

Own and maintain the proposed stormwater drainage infrastructure containing approximately 80 linear feet of 15" reinforced concrete storm sewer and an outfall into the west arm of Vadnais Lake including erosion control protection at elevation 883.00.

2. Conditions

All work to be performed in accordance with good engineering practices subject to approval by the Board's Vadnais Supervisor

3. Notification

City or City's contractor to notify Board's Vadnais Supervisor at least 48 hours in advance of permitted activity to schedule coordination of work. Board's Vadnais Supervisor can be reached between the hours of 8:00 a.m. and 4:00 p.m. at 651-766-4150

4. <u>Insurance</u>

Pursuant to Section 29 of the Agreement, City's contractor to provide a certificate of insurance naming the Board of Water Commissioners and the City of Saint Paul as additional insureds with respect to general liability and automobile insurance. Work not to commence prior to Board approval of said certificate.

Section 29 of the Agreement is hereby amended to require public liability insurance in minimum amounts of \$1,500,000 for any number of claims arising out of a single occurrence, for bodily injury or death, and \$1,500,000 for damages to or destruction of any property.

This section not to apply when work is performed by City's forces; rather, the provisions of Chapter 466, Minnesota Statutes will apply to work performed by the City and/or its employees.
