- Go to Benefits and select View All.
- Scroll down to select Labcorp Biometric Screenings tab
- Click the onsite screening tab
- Available appointment times will appear
- Select the time slot that works for you

Completing the health screening will earn you 1,000 reward points. You need 1,500 points to earn \$300 in Health Reimbursement Account money and 3,500 points to claim the entire \$900 in Health Reimbursement Account money. You can also earn up to \$320 in additional cash by earning additional points.

Mary Kennicutt, retiree, passed away the last week in January. She was 89 years old.


She worked Mary Kennicutt at the water

Claim reimbursement for 2022 FSA money by Feb. 15

Make sure you get reimbursed for all of the money you put into your 2022 flexible spending account.

You will lose money remaining in your 2022 FSA account you have not claimed by Feb. 15. If you signed up for an FSA both this year and last year, you will be allowed to carry over \$500 from last year into 2023.

Flexible spending accounts can be for medical expenses, dependent care, and parking.

The company handling all FSA and health reimbursement accounts/VEBA accounts is Benefit Resource, Inc.

Their website is BenefitResource.com.

If you have an FSA or VEBA/HRA account, you should have received an email, mailing, or handout

from BRI/or the city on their behalf providing you with instructions on how to check on the balances in your account with them.

If you have not used the site before, go to their website and click on the register an account link. Follow the instructions.

You will need your social security number, company code (StPaul), name, zip code, and email or phone number.

Use the site to look up balances and file for reimbursement for 2022 claims.
