This is to confirm that at Legislative Hearing on March 28, 2023 Legislative Hearing Officer Marcia Moermond will recommend that the City Council **order the building removed within 15 days unless Wells Fargo submits a commitment letter indicating their decision to remove or repair the property** by no later than close of business April 7, 2023.
