Dear Ms. Miller and Mr. Thooft:

This is to confirm that at the Legislative Hearing on Tuesday, June 13, 2023 this matter was continued to Legislative Hearing Tuesday, June 27, 2023 via phone between 10:00 a.m. and 12:00 p.m. for further discussion and update on issuance of pending Code Compliance certificate.

As we discussed, you need to contact Building Inspector Clint Zane at 651-266-9029 (between 7 and 9 am) to have him visit the property to final your building permit and issue the Code Compliance certificate before June 28. If this is done prior to the June 27 Legislative Hearing that hearing can be cancelled and the matter will go before the City Council on June 28 indicating the nuisance is abated and matter resolved.
