Sir or Madam:

The Safety and Inspections Department has ordered certain capital improvements and repairs to be made at a single-family dwelling: 571 South Saratoga Street in Saint Paul. The order was directed to Mark S. Finley, who occupies the property. The order was in the form of a Fire Inspection Correction Notice issued under Chapter 40 of the Saint Paul City Code. The Inspector apparently believed that the property is occupied by a non-owner.

Appellant appeals the order on the grounds that he is an <u>owner</u> of the property. Chapter 40 of the Saint Paul City Code expressly <u>exempts</u> owner-occupied single-family homes from the fire certificate of occupancy requirement. Therefore, there is no jurisdiction for the Safety and Inspections Department to make this order. Please consider this letter as evidence submitted into the record of the appeals hearing.

Mark S. Finley is an occupant of the property and has been an occupant continuously for several decades. Mark S. Finley has also been a joint <u>owner</u> of the property since his father, William G. Finley, died "intestate" (that is without a Will) on October 12, 2006. Because of this, Safety and Inspections Department, though clearly acting in good faith, has no authority to issue a Fire Inspection Correction Notice against the Property.

Attached to this letter is a true and correct copy of a Petition for Determination of Descent and of a proposed Decree of Descent. Both these documents were filed with the Ramsey County Probate Court, together with \$320 filing fee, on Friday, March 2, 2012. To confirm the filing of these materials, please contact Jannie Baltes, one of the clerks of Probate Court, at 651-266-8143. (Inquire after filings in the "Estate of William G. Finley")

Attached to the Petition for Determination of Descent is a copy of the certified death certificate of William G. Finley, stating that his date of death was October 12, 2006. The Petition also avers, and I have personal knowledge of the fact that, William G. Finley had only two heirs: Mark S. Finley and George G. Finley, both of whom are his sons. William G. Finley's spouse predeceased him. The Petition also avers, and I can confirm from personal knowledge, that William G. Finley died without a Will – that is, he died "intestate."

The Uniform Probate Code, as enacted in Minnesota, provides that title to real estate, owned by a decedent who died intestate (such as William G. Finley), vests in the decedent's heirs by operation of law. See Minnesota Statutes §§ 524.2-101 and 524.2-103. This vesting of real estate in heirs occurs automatically without the need for any probate or court procedures. Moreover, case law makes clear that when a decedent dies intestate, title to the decedent's real estate vests immediately in the decedent's heirs-at-law. See Bengtson v Setterberg, 227 Minn. 337, 35 N.W. 2d 623, (1949); Bemboom v. National Surety Corporation, 225 Minn. 163, 31 N.W. 2nd 1 (1947); Hardenberg v. Comm. of Internal Revenue, 198 F. 2nd 63 (8th Cir. 1952), cert. denied, 344 US 836, 73 S. Ct. 45. Thus, under Minnesota law, since October 12, 2006, the actual owners of 571 South Saratoga are Mark S. Finley and George G. Finley, the sons and the heirs-at-law of decedent William G. Finley.

The probate proceeding Mark Finley has initiated will clear up out-of-date County records regarding ownership, but the fact remains that Mark Finley has been an <u>owner</u> of 571 South Saratoga since October 12, 2006, that his occupancy of the property is as an <u>owner</u>, and that the property is therefore <u>exempt</u> from Chapter 40 of the City Code.

With this explanation my hope is that the City will withdraw the orders it has placed against 571 South Saratoga.




