## NOTICE OF INTENT TO REVOKE LICENSE

Nasseh Ghaffari-Nikou Heartland Auto 877 Westminster Street St. Paul, MN 55130

Auto Body Repair/Painting Shop license held by Heartland Auto Sales, Inc. d/b/a Heartland Auto for the premises located at 877 Westminster Street in Saint Paul License ID #20060002711

Dear Mr. Ghaffari:

The Department of Safety and Inspections (DSI) has recommended adverse action against the Auto Body Repair/Painting Shop license held by Heartland Auto Sales, Inc. d/b/a Heartland Auto for the premises located at 877 Westminster Street in Saint Paul. The basis for this determination is as follows:

On January 24, 2012, a DSI Inspector conducted an inspection of the licensed premises and found multiple violations to your license conditions:

- 1) Two cars were parked on the street registered to you in violation of license condition #4 which states: "At no time shall vehicles be parked in the driveway or the public right-of-way. Vehicles awaiting repair may not be parked or stored in an alley."
- 2) The inspector observed trash, auto parts and barrels of oil stored outside around the property in violation of license condition #3 which states: "There shall be no exterior storage of vehicle parts, tires, oil or other similar materials associated with the business. Trash will be stored in a covered dumpster. Storage of vehicle fluids, batteries, etc. shall be in accordance with the Ramsey County Hazardous Waster regulations."
- 3) The inspector noted at least one inoperable vehicle stored on the property with no windows and front end damage in violation of license condition #5 which states: "Storage of vehicles for the purpose of salvaging parts is expressly forbidden. All vehicles parked outdoors must appear to be completely assembled with no major body parts missing. Vehicle salvage is not permitted."

As this is the fourth (4<sup>th</sup>) violation to your license conditions within the past twenty-four (24) months; therefore, the licensing office will recommend revocation of your Auto Body Repair/Painting Shop license.

At this time, you have two options on how to proceed:

- If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul 1. City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by Monday, February 27, 2012. The matter will then be scheduled before the City Council for a public hearing to determine whether to revoke your Auto Body Repair/Painting Shop license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). 3. You will need to send me a letter no later than Monday, February 27, 2012, disputing the facts and requesting an administrative hearing. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

If you have not contacted me by Monday, February 27, 2012, I will assume that you do not contest the revocation of your Auto Body Repair/Painting Shop license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
