Dear Mr. Bloomquist:

I received your faxed letter requesting an administrative hearing which I have now scheduled for Monday, April 2, 2012. You will be receiving an official Notice of Administrative Hearing and exhibits in the next few weeks.

Please be aware that because this is now the fourth (4<sup>th</sup>) violation to your client's license conditions within twenty-four (24) months, the licensing office (DSI) will also recommend to the City Council that they impose the costs of the administrative hearing pursuant to Saint Paul Legislative Code § 310.05 (k) which states:

"Imposition of costs. The council may impose upon any licensee or license application some or all of the costs of a contested hearing before an independent hearing examiner. The costs of a contested hearing include, but not limited to, the cost of the administrative law judge or independent hearing examiner, stenographic and recording costs, copying costs, city staff and attorney time for which adequate records have been kept, rental of rooms and equipment necessary for the hearing, and the cost of expert witnesses. The council may impose all or part of such costs in any given case if (i) the position, claim or defense of the licensee or applicant was frivolous, arbitrary or capricious, made in bad faith, or made for the purpose of delay or harassment; (ii) the nature of the violation was serious, or involved violence or the threat of violence by the licensee or employees thereof, or involved the sale of drugs by the licensee or employees thereof, and/or the circumstances under which the violation occurred were aggravated and serious; (iii) the violation created a danger to the public health, safety or welfare; (iv) the violation involved unreasonable risk of harm to vulnerable person, or to person for whose safety the licensee or applicant is or was responsible; (v) the applicant or licensee was sufficiently in control of the situation and therefore could have reasonably avoided the violation, such but not limited to, the nonpayment of required fee or the failure to renew required insurance policies: (vi) the violation is covered bye the matrix in section 409.26 of the Legislative Code; or (vii) the violation involved the sale of cigarettes to a minor."

Based on this information, if you choose not to move forward with an administrative hearing, you still have the option of appearing before City Council at a public hearing. Please let me know by Monday, March 5, 2012, which hearing you have decided to pursue.
