Mayor Coleman -

I'm a Summit Hill resident and served 2 years on a joint GABA/SHA Parking Task Force, so I'm familiar with the challenges of parking for businesses (and residents) in our area. I wish to make a few brief points:

1) Parking problems take years or even decades to resolve. If a few extra weeks or months helps to form a workable solution in any particular instance, that solution and time-frame should be welcomed.

2) I'm sympathetic to the challenges for small businesses, as I am to all neighbors (businesses and residents) that will have to live for many years with whatever solution is achieved. While zoning/permit issues are confusing for all involved, it is naive for a small business to consider locating on Grand Ave. and not be aware that such issues will need to be addressed. Any commercial rental or leasing agent would also be well-aware of that need.

3) This particular situation is not uncommon. The building that was allowed to be built/developed at that location was too big/grand/expensive for its space. The owner/developer is then stuck - they need a high-rent tenant to make ends meet. The high-rent tenant needs space/infrastructure that isn't there - The city and neighbors are then pressured to allow it...

4) Finally, zoning variances are permanent - lease arrangements for individual off-site parking spaces are temporary. If a variance is granted, the terms should be enforceable over the long-term on the present and any subsequent tenant.

I wish you and the City Council and our neighborhood representation (SHA) good will and patience as you work toward a solution.
