Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for Wednesday, May 2, 2012 at 5:30 p.m., in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

This is an uncontested matter concerning the fact that on March 2, 2012, you submitted an application to obtain a Taxicab Vehicle license for Cab #1531.
