NOTICE OF INTENT TO DENY LICENSE

Dear Mr. Estrada:

The Department of Safety and Inspections (DSI) has recommended adverse action against Auto Repair Garage license application submitted by Pronto Auto Repair, Inc. d/b/a Pronto Auto Repair for the premises located at 1054 Payne Avenue in Saint Paul. The basis for the recommendation is as follows:

On July 3, 2013, you were sent a letter from the Department of Safety and Inspections (DSI) indicating that your Auto Repair Garage license was still "pending" because you failed to submit the following information required to complete the application process:

- 1) Sign and return one copy of the license condition affidavit that was enclosed with the letter acknowledging the conditions that will be placed on your license(s).
- 2) Provide a valid Minnesota sales tax identification number.
- 3) Submit a copy of a signed business purchase agreement.
- 4) Submit a copy of a signed lease, or letter of permission from the property owner, specifically allowing you to operate an auto repair service business on the property.
- 5) Provide proof of having obtained workers' compensation insurance: insurance company name policy number, effective date and expiration date for the insurance.

According to DSI records, Kris Schweinler, Senior DSI Inspector hand-delivered the July 3, 2013 letter to you on August 1, 2013 and did an inspection only to find you were not in compliance. She informed you that you would need to bring the establishment into compliance and call her to come for a re-inspection before the license could be issued.

As of today's date you have not contacted Kris Schweinler to come for a re-inspection or submitted the required information to complete the application process. Therefore, per Saint Paul Legislative Code § 310.06 (b) (5) the licensing office will recommend denial of your Auto Repair Garage license.

At this time, you have three options on how to proceed:

- 1. You can call Kris Schweinler (651) 266-9110 to schedule your re-inspection and submit the required information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **September 23**, 2013. A self-addressed envelope is enclosed for your convenience. Scheduling your re-inspection and submitting required information will be considered to be a waiver of the hearing to which you are entitled.
- 2. If you wish to <u>admit</u> the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. I will need to receive your letter by **Monday**, **September 23**, **2013**. The matter will then be scheduled before the City Council for a public hearing to determine whether to deny your Auto Repair Garage license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
 - 3. You may withdraw your license application. Send a written statement to that effect to the Department of Safety and Inspections (DSI), 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, September 23, 2013. Information should be directed to the attention of Christine Rozek. Any request for a refund of the license application fee must also be made in writing to the Department of Safety and Inspections.

If you have not contacted me or DSI by Monday, September 23, 2013, I will assume that you do not contest the denial of your Auto Repair Garage license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
